 Is there value in keeping outside evaluators who are experts in our field? Perhaps for disciplines that do not have faculty that they feel can accurately assess their disciplines.



-A reminder to all faculty: Faculty have the right of refusal to anyone on their committee. Experiences of outside faculty both positively or appropriately contributing to evaluations was voiced. We should examine the contract, discuss at the next meeting, and then vote at a future meeting after more research and discussion.

4.1.4. Adjunct Evaluations- Faculty of Record should be a part of the evaluation committee. Comments from the body:

-Currently, the evaluation committee consists of the Dean and the Chair who base evaluations on student feedback and other items. Timeline for faculty evaluations is tied to our fiscal year and are offered 6 month or 1 year contracts. Confirmed by Tim and Gus (Chairs)

4.1.4.1. What is the criteria for adjunct evaluations? Comments from the body:

-Are faculty contacted if there are student complaints or other concerns? Do we put adjunct faculty on performance plans to help, should that be necessary?
This provides another argument for bringing adjunct faculty into the union. One full-time faculty asked adjunct faculty in his area if they would join the current union (as opposed to stating their own) and all asked said yes.
