  - C. SSCCC General Assembly Discussion Item (10 minutes)[2:31pm]

- 1. From April 4 to 6, representatives from Calbright College participated in the SSCCC General Assembly, a statewide event that brings together student government leaders from California community colleges. Deb Hemingway served as the voting delegate and reviewed 90 student-led resolutions that addressed campus-wide concerns and proposed future legislative priorities. The event provided a valuable opportunity to witness the democratic process in action, connect with other student leaders, and share the innovative work Calbright is doing, including programs like TimelyCare and communication through Slack. Chris and Amna offered strong guidance throughout the event, helping ensure a successful and impactful experience. The assembly highlighted the power of student voices in shaping policies and advocating for meaningful change across the state.

- E. ASCC Constitution & Bylaws Review Discussion Item (15 minutes)[2:41pm]
  - 1. The ASCC is currently reviewing and updating its governing documents, which include the constitution and bylaws, to better reflect the current structure and operations of Calbright College's student government. These documents were originally drafted in 2022 and implemented in 2023, but since then, Calbright has evolved significantly. Updates aim to modernize language, include new procedures such as the use of Slack, and align position descriptions with current responsibilities. One major change includes officially retiring the term SBO (Student Body Organization) from all titles and replacing it with ASCC to maintain consistency. The leadership team is working on revisions, and members will soon receive access to review the

documents, provide input, and ask questions before a finalized draft is shared with the student body for feedback and a vote. These changes are intended to be in effect by Term 2 and will help ensure clarity, transparency, and alignment across student government roles moving forward.
